## Ad Hoc Reporting (continued)

Traverse have the ability to create single-purpose reports through integration with other tools.

OSAS has both the GENERAL Report Writer and ODBC for such reporting. The OSAS GENERAL Report writer will produce fully-formatted reports or output to files (CSV and fixed-length record). OSAS version 6.5 can output individual statements to comma separated variable (CSV) files.

ODBC provides data to ODBC-compliant software through a common interface. There is usually a less sophisticated output formatting capability since the product performing the ODBC request (Microsoft Word, Excel, Access, Crystal Reports and a number of other products) is assumed to be able to address data selection and report formatting requirements.

Because ODBC interface is native in Traverse, no add-on software is required to use the ODBC interface. OSAS requires the ODBC Connection add-on module. With it, users can export data into files and other databases. There is no ongoing connection to the database once the initial export has been accomplished, so the OSAS data represents a "snapshot".

#### Indiana Local Taxes

Effective July 1, 2004, 89 of the 92 Indiana counties will have a local payroll tax requirement. Twenty of the 89 counties will change rates on that date. Remember that check date, not pay period ending date, determines the income reporting period and applicable tax rate.

## **Technology Corner: Antivirus Updates**

Hardly a day goes by that we don't hear about another "computer virus". Nearly every antivirus product requires a periodic update to the virus dictionary to maintain its ability to recognize and quarantine such new viruses.

An annual subscription fee assures access to such updates, but does not force you to obtain them. In most cases, the update can be downloaded via automated schedule. Depending on the product, deployment may require human intervention. An out-of-date definition file only provides a false sense of protection since it is usually the latest viruses that infect a system, not the older ones.

Make sure that your antivirus product remains capable of intercepting and disabling viruses by subscribing to, downloading and distributing the updates!



## eCommerce

eCommerce is the term used to describe web-enabled business. The "shopping cart" model is the most common eCommerce presentation, but certainly not the only form that eCommerce can take. Both OSAS and Traverse have eCommerce capability, ranging from the posting of safeguarded data to business web sites, customer response documents (registration, email, information request, etc.) to the aforementioned shopping cart capability.
