

Firewalls: Don't Get Burned!



You may have encountered the term "firewall" in connection with your Internet connection. In brief, a firewall prevents unwanted external access to your internal network. It may be a part of your network hardware, or may simply be software installed on a ser

hardware, or may simply be software installed on a server. Which ever approach you take, you should not have ANY full-time Internet connection (DSL, cable, etc.) without implementing a firewall! ABS can assist with your firewall implementation upon request.

New General Ledger Year: Traverse

Many of our clients are "not-for-profits" with a fiscal year running from 7/1 - 6/30. While Traverse will permit any number of unclosed years in history, there are a few steps that must be performed before posting in a new fiscal year. In brief, they include:

- 1. Make sure that all income statement accounts have an account type between 500 and 890, inclusive, and that balance sheet accounts have an account type between 5 and 465.
- 2. Income statement accounts have a step of 1 or greater and a clear-to account specified
- 3. Use System Manager, Company Setup, Period Conversion to set up periods for the new year.
- 4. Use General Ledger, Periodic Processing, Year-End Maintenance to add a year if necessary.
- 5. Use General Ledger, Periodic Processing, Change Fiscal Year to change to the new fiscal year. You must be in the New Year to perform step 6!
- 6. Use General Ledger, Periodic Processing, Update Current Year to set beginning balances in balance sheet accounts and perform a mock close on income statement accounts. Remember that when any postings affect prior year account balances (and GL Post to Master has been run), an Update Current Year should be run again in the current year to bring the appropriate beginning balances into the new fiscal year.
